Manufacture and sale of TEN caps and lightweight caps

Established in 2014 as a joint venture with a Taiwanese plastics manufacturer, Nihon Yamamura Glass acquired full ownership in 2009. Zhancheng (Suzhou) Plastic produces plastic beverage caps for sale primarily in China as well as South Korea, Taiwan, and Southeast Asia. Sales of TEN caps are excellent, with the focus on product development increasing the number of new products.

Manufacture and sale of TEN caps and lightweight caps

Initially established in 2010 as a joint venture with San Miguel Yamamura Packaging International, our joint venture with San Miguel Corporation. Nihon Yamamura Glass acquired full ownership in 2012. The company produces plastic beverage caps, with sales primarily to local Japanese-affiliated companies, and Indonesian companies, and sales in Southeast Asia and China. Moving forward, the company will engage further in local product development.

The company sells a wide variety of packaging containers, including glass bottles, mainly in the Philippines but also across the globe through manufacturing and sales bases in Australia, New Zealand, Malaysia, Vietnam, and China. In addition to selling bottles, corks, and other products in Australia, San Miguel Yamamura Packaging is actively expanding its business domain by filling, exporting, and directly selling wine. San Miguel Yamamura Asia, which was established in 1991 as Nihon Yamamura Glass' first overseas glass bottle manufacturing and sales base, was integrated with San Miguel Yamamura Packaging in March 2020 to create greater synergy with the expanding packaging business and is now the company's main factory.

Yamamura Kinik Optical was established as a joint venture with Kinik Company. The company manufactures and sells aspherical glass lens products that focus or collimate light from lasers or other sources. These products are used for optical communications, projectors, detectors, and various other applications. Optical communication applications in particular are expected to grow significantly in the future due to the increased needs for high-speed, large-capacity, low-latency, and multiple connections that come with the spread of 5G technology.

The company also coordinates with other Yamamura Group companies with the aim of expanding sales of glass bottles beyond the main target of wine to the spirits and sake markets in the USA.

In February 2019, Yamamura International California moved its offices from Napa to Walnut Creek.
